## STATEMENT OF COOPERATION

1. We have read the Truth And Freedom Home School Academy Handbook, and we have agreed to comply with all the policies and requirements stated therein.
2. We agree with the Statement of Faith which is stated in the Truth And Freedom Home School Academy Handbook.
3. We will select and purchase the curriculum to be used during the school year for each child.
4. We will submit a Curriculum Log for each child, the first year of enrollment only, indicating the purchased curriculum within thirty days of our enrollment date.
5. We will maintain an Attendance Record for each child during each school year, indicating a minimum of 160 days of attendance per school calendar year. We will record this information on the Student Progress Report, which summarizes the cumulative educational progress and accomplishments of each child. The Student Progress Report will be due twice a year. The first report will be due on February 1<sup>st</sup>, and the second report will be due on August 1<sup>st</sup>.
6. We will maintain our own copies of student files for each child which will include Registration forms, Public School Notification of Church School Enrollment, and Progress Reports.
7. Enrollments are accepted throughout the year. However, we understand that we must re-enroll our child and/or children with Truth And Freedom Home School Academy by June 1<sup>st</sup> of each school year, and that a \$10.00 late fee will be due if we re-enroll after June 10<sup>th</sup>. We realize that if we fail to enroll by June 15<sup>th</sup>, withdrawal of my child and/or children from Truth And Freedom Home School Academy will result. We realize that we will become subject to truancy laws, if we fail to enroll our child and/or children elsewhere.
8. We agree to release the Truth And Freedom Home School Academy School Administrator and any Support Staff from all responsibility or liability for the education as well as the social or physical well being of our child and/or children. By signing this document, we agree to assume all risk for the well-being of our child and/or children during any classes, functions or activities sponsored by Truth And Freedom Home School Academy.
9. We realize that there are no refunds if we enroll in Truth And Freedom Home School Academy, and then, withdraw from Truth And Freedom Home School Academy, and decide to enroll elsewhere. We also realize that there will be a \$50.00 withdrawal fee.
